**Provenance:** Abatement records were received from the town clerk in 1976. Board of Assessors valuation and street books created between 1861 and 1926 were received from the town clerk in 1987. The immediate source of other items in this collection is unknown.

**Processing information:** Records were previously processed by Watertown Free Public Library staff and catalogued as several individual items and collections. This finding aid was created by Caroline Littlewood in 2020 to unite items created by the Town of Watertown Board of Assessors. It is adapted from catalog records and draws heavily on an inventory of the East Branch of the Watertown Free Public Library completed in 2006.

**Conditions governing access:** Collection is open for use in the Local History Room, Watertown Free Public Library.

**Abstract:** This collection documents the activity of the Town of Watertown Board of Assessors. It contains tax and valuation lists, assessor's certificates and certificates of abatement, tax warrants, board correspondence, meeting minutes, and notes.

## Historical Note

The Board of Assessors is the town body responsible for the fair and equitable listing and valuation of all property, real and personal, subject to taxation. Their work is essential to the levying and collection of town, county, and state taxes.

Within years of English settlement, Watertown selectmen ordered the assessment and taxation of property. They called for two or three men to take and "perfect" an "invoice of men's estates to make rates" for the upcoming year:

the Invoice shall from time to time be taken; in two or three sheets of paper fixed together... and in the margin upon the left hand...in alphabetical order the names of persons concerned in the rate (in payment) and in the uppermost margin, the particulars to be rated, with their value, and underneath (right against every man's name) the particular sum that he hath of every specious... and this invoice so taken, shall be kept in some man's house...for every man to...see he hath no wrong; and so to continue till a new Invoice be taken.<sup>1</sup>

Seventeenth-century assessments were performed sporadically by one or two men and revisited annually. Assessments typically included real estate valuations, personal estate valuations, and lists of polls (males sixteen years of age or older). By the end of the 1600s, Watertown had standard assessment procedures in place. Each year, the town appointed three to five men to act as Assessors. The Assessors notified residents of upcoming assessments and recorded, appraised, estimated, and valued all taxable estates and polls. Then, they submitted the tax and valuation lists for review by the Selectmen and the public. Assessors were also empowered to abate taxes in exceptional circumstances. Upon completion of their work, they deposited the lists and abatements with the town Collector. Assessors also regularly communicated with county and state officials about individual assessments and, when the tax code became more complex in the nineteenth century, compiled valuation books to submit to those officials.

## Scope and Content Note

This collection documents the work of the Board of Assessors. It contains tax and valuation lists, assessor's certificates and certificates of abatement, tax warrants, board correspondence, minutes, and notes.

### Series I. Tax and valuation lists, 1775-1916 (inclusive)

This series consists of tax and valuation lists and books. The distinction between tax list and valuation list is not always clear; items labeled "valuation" may also include tax sums and items labeled "tax" may include valuations. Some items are labeled "Tax book" on the spine, and "Valuation and Tax book" on the cover.

All materials contain lists of individual persons or corporate bodies to be taxed along the left column of the page, and items to be tallied or valued along the top row. Some are original handwritten assessments (typically referred to as "lists"), others are compiled reports for government bodies (typically, though not always, referred to as "books"). Because some items in this series are original records and others are derivative records (having been created with the information in the originals), items for the same years often contain duplicative data. For example, the valuation books of the early twentieth century include transcriptions of information originally collected in that year's list(s). The data is neatly organized in pre-printed pages of books provided by the Commonwealth, with more entries to a page than in the lists for that year. However, some of the lists have notes in the margins which are not duplicated in the valuation books.

Lists and books vary in the amount of description of property, although later volumes tend to provide slightly more description. Items referred to as "tax lists" or "valuation lists" generally include assessments of personal and real estate, at a minimum, as well as polls and assessments or rates for other tax or property categories (e.g. highway tax, ministry tax). A handful of lists and books are exclusive to a single tax, e.g. carriage tax, street watering tax, or poll tax. Some labeled tax book list state and county taxes, as well as town taxes. A small number include other types of information. For example, some 1790s and 1800s lists include individuals' honorifics and/or occupations, and the 1887-1888 poll tax assessment includes previous residence (town, state, or country). Lists and books also vary in organization: some are alphabetical, some are geographical. Later lists are more often alphabetical than by street, except for Street books.

## Series II. Meeting and abatement records, 1766-1926 (inclusive)

This series contains six bound volumes of Board of Assessors meeting minutes (1895 to 1926), one index to abatements (1904 to 1910), and five folders of loose abatement lists, abated bills, certificates of abatements, and notices to Collectors. It also includes the Report of the Committee on Allowances to Collectors of Taxes, submitted in 1784 (box 35, folder 3). Board of Assessors meeting minutes primarily document tax abatements granted by the Board, though they also include reference to valuations conducted by the Assessors and errors to be resolved. Generally, abatement lists and notes include the name of parties and/or property involved, the amount abated, and, from the late nineteenth century onward, the reason for the abatement (i.e. "dead," "poor," or "widow's right").

This subseries contains printed folios describing state acts to apportion and assess taxes within all municipalities and state warrants for the assessment of taxes within Watertown. Warrants are on printed sheets, with the town (Watertown) and the amount of taxes levied handwritten in. It also contains state notices and directives regarding other matters related to taxation, including an act "to provide for the collection of taxes in cases where the constable or collector has removed themselves out of the Commonwealth" and a resolve granting selectmen the right to examine collectors' lists.

Subseries ii. Middlesex County warrants, 1781-1841 (inclusive)

This subseries contains warrants for the county tax.
